ORDINANCE NO. 2015-04

AN ORDINANCE FOR THE LEVY & ASSESSMENT  
OF TAXES FOR THE CURRENT FISCAL YEAR

Whereas, the President and the Board of Trustees of the Village of Loda, in the County of Iroquois and the State of Illinois, did the 8th day of July 2015, pass the Annual Appropriation Ordinance for said Village for the fiscal year beginning on the 1st day of May 2015, the amount of which is ascertained to be the aggregate sum of Four Hundred Thirty-Eight Thousand Three Hundred Fifty Dollars (\$438,350.00) and which Appropriation Ordinance was duly posted.

BE IT ORDAINED by the President and Board of Trustees of the said Village of Loda, Illinois:

SECTION I

That there be and is hereby levied upon all taxable property within the corporate limits of the said Village of Loda, Illinois, subject to taxes for the year 2015, the total sum of Twenty-Two Thousand Nine Hundred Dollars (\$22,900.00) for the following specific purposes mentioned in said Appropriation Ordinance and in the respective sums as follows, to-wit:
